No student will be permitted to use personal technology devices unless the agreement is signed and returned.

Students and parents participating in BYOD & 1:1 Devices must adhere to the Golden Bay High School Student Code of conduct, as well as all Board policies, particularly Internet Acceptable User Policy and Internet Safety Policy.

Please read carefully and students initial every statement:

Signature	Guidelines for BYOD & 1:1 Device Users - Please sign next to each guideline below
	Students take full responsibility for their devices. The school is not responsible for the security of personal technology. Personal devices cannot be left at school before or after school hours.
	Devices cannot be used during assessments, unless otherwise directed by a teacher.
	Students must immediately comply with teachers' requests to shut down devices or close the screen. Devices must be in silent mode and put away when asked by teachers.
	Students are not permitted to transmit or post photographic images/videos of any person on school grounds on public and/or social networking sites.
	Personal devices must be charged prior to bringing them to school and run off their own batteries while at school. Charging will be available on a limited basis and is up to teacher discretion.
	To ensure appropriate network filters, students will only use the student wireless connection in school and will not attempt to bypass the network restrictions in anyway or by using 3G or 4G network.
	Students understand that bringing devices on premises to infect the network with a Virus, Trojan, or program designed to damage, alter, destroy, or provide access to unauthorized data or information is in violation of the AUP policy and will result in disciplinary actions.
	Golden Bay High School has the right to collect and examine any device that is suspected of causing problems or is the source of an attack or virus infection or is suspected of containing pornography / objectionable material obtained offsite and stored on the Student Owned Device.
	It is the owner's responsibility for the repair of any malfunctioning / damaged devices. Golden Bay High School does not supply technical services for student owned devices.
	Students should not physically share their personal devices with other students, unless they have written parent permission to do so.
	If a student on sells a device or misplaces a device they must inform the technicians. Until this has been done the individual registered to that device is still responsible for the device.
